Statutory Declaration

Applicants not satisfied with the reply of the PIO or having grievances in the information so provided, can file appeal to the Principal, who is the first appellate authority. The decision of the Appellate Authority is binding on the institution and will be properly communicated to the appellant within the prescribed time limit. If the grievance still persists, one can still file an appeal to the next higher authority (that is the Director of Collegiate Education).
